## Gearing up for Safer Internet Day

## ACT libraries become eSafe spaces

Young people in the ACT are among the first to trial a new program—[eSafe spaces](#)—through ACT libraries. In November, library staff were trained by the Office's experienced online safety trainers in ways to help young people deal with cyberbullying and how to make cyberbullying reports. If successful, eSafe Spaces will be rolled out to 1500 public libraries across Australia in 2016.

Putting photos and videos on social media is a great way to share with friends, family, and your community. But when the images are of children, there can be risks.



## Online safety gets a boost with provider certification underway

Schools will have greater certainty when choosing online safety education programs as the Office has published an inaugural list of [certified online safety providers](#).

Over the next three months we're also making it easier to [apply to be a certified online program provider](#), by offering a provisional certification status. You can submit your application without insurances or Working for Children Checks and will be listed on our website as having 'provisional certification'. Providers will, however, need to submit these document to receive formal certification.



## Revamped Cybersmart Detectives available soon

Building on the success of our in-school program, [Cybersmart Detectives](#) has recently been redesigned and updated into an online program.

Designed for children in Year 4, Cybersmart Detectives is an animated teaching resource using a 'real world' example which explores what may happen if someone reveals too much information online. The interactive program includes worksheets and lesson plans.


